## Regarding Summer Intensive Classes and Extracurricular Activities under the Priority Preventative Measures

Currently, the spread of COVID-19 has been progressing nationwide, and Kochi Prefecture also has been applying the government-mandated Priority Preventative Measures (scheduled from August 27 to September 12).

Due to this situation, summer intensive classes and extracurricular activities during the summer are handled as outlined below.

As for the handling of second term classes starting in October, we plan to make an announcement around the middle of September.

### 1. Summer Intensive Courses

Courses that were originally intended to be held face-to-face will be changed to online classes wherever possible. However, depending on the nature of the course, some will still be held face-to-face. Please check the instruction method for each of the classes that you are planning to take.

If due to participation in teaching practice or job hunting, you are unable to return to Kochi one week prior to the start of the face-to-face classes, or if you are absent from class due to illness or other unavoidable circumstances, you may be permitted to withdraw from the classes. In such a case, please contact the Educational Department in advance.

### 2. Extracurricular Activities

According to the "Priority Preventative Measures," which will go into effect in Kochi Prefecture from August 27, based on the government-mandated "Basic Policies for Novel Coronavirus Disease Control," we ask that you refrain from extracurricular activities as stated below.

#### (1) Self-Restraint Period (No group activities)

August 27 (Fri) - September 12 (Sun)

\*This period may be extended if the Priority Preventative Measures period is extended or if the State of Emergency is announced.

#### (2) Self-Restraint Requests

- Face-to-face group activities (practice, competitions, and other external activities, etc.) are prohibited.
- Individual voluntary practice (around 2 to 3 people) is acceptable. The use of sports facilities for voluntary practice is permitted.

### 3. The university arranged vaccination

(1) As we announced previously, starting in October, Kochi University Oko Campus will be a vaccination site for students of our university. Within a few days, we will contact you by portal notification about the official application for vaccinations and other information. It is fine if

your official application is different from your responses to the intention survey we conducted in July.

- (2) You must submit your "Vaccine Card," even if you decide to getting vaccinated by university arrangement. When the card arrives at the address written on your certificate of residence, please be prepared to obtain it, such as by having it mailed to you, etc.
- (3) Students wishing to receive the university arranged vaccination must return to Kochi 14 days before the vaccination date, so please keep that in mind.
